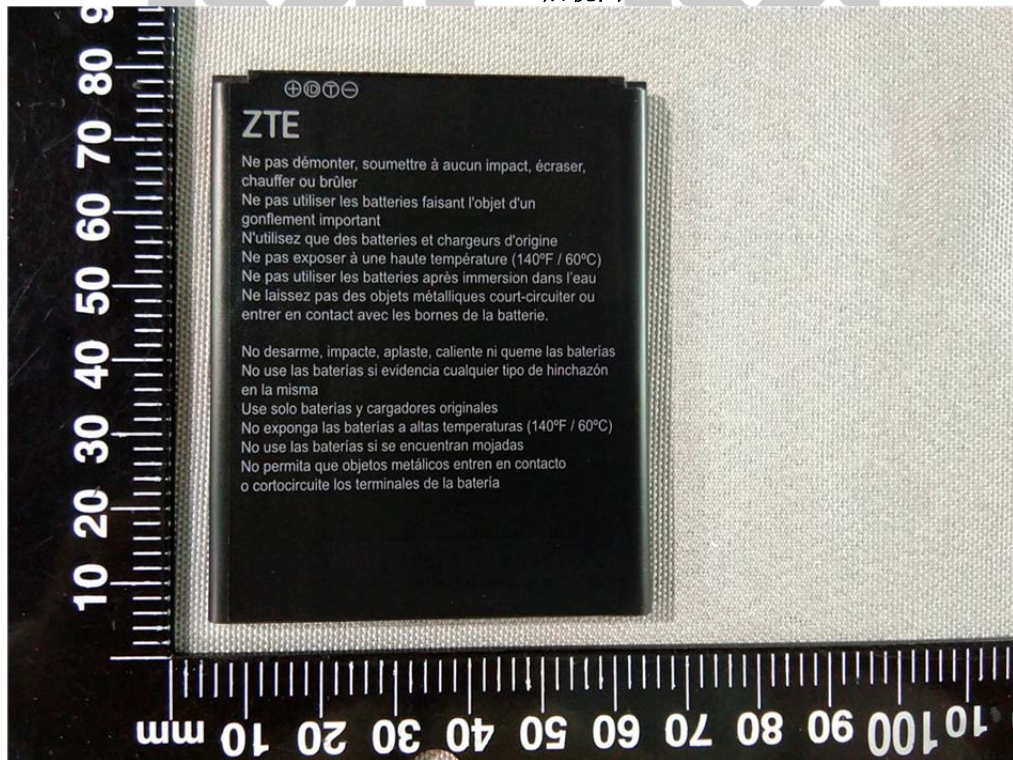

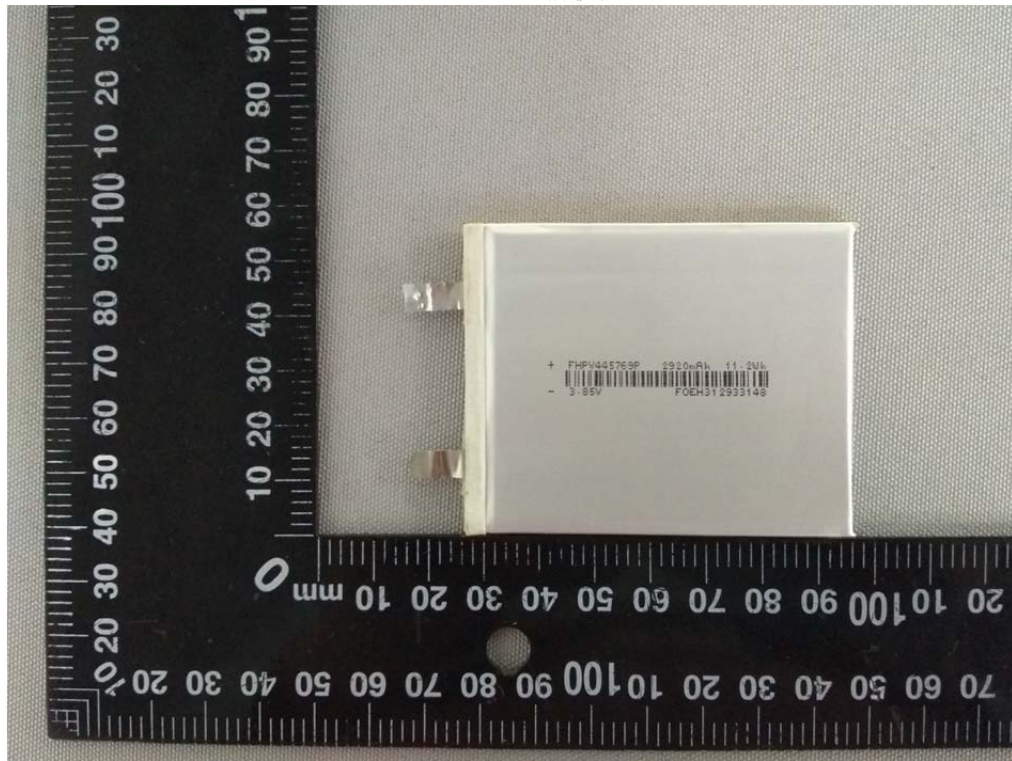

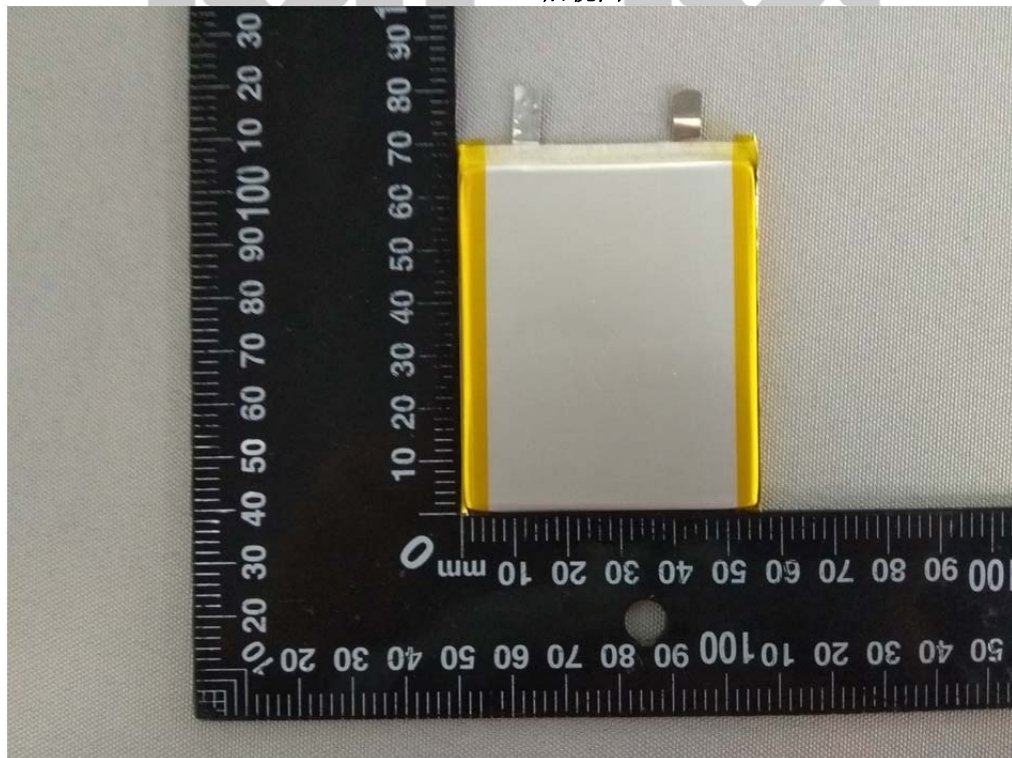


Photos of the Cell 电芯照片
